- The individual recognized does not have to be a member of the Greater Nashua Chamber of Commerce or the business community. They may serve on service, school, church, and/or community committees. They may be an individual from any walk of life, and there are no requirements or restrictions with regard to gender, race, religion, sexual orientation, or ethnic background.
- •A person with demonstrated honesty and integrity who has shown a willingness to work with other Greater Nashua residents, who is enthusiastic about the city and its citizens, and who works towards the betterment of the community.

Nomination Procedures and Rules

•Complete and submit this form, along with a brief bio of the nominee, answers to the questions on the reverse side of this form and any letters of recommendation, no later than **Tuesday, September 17, 2024 at 5pm.**

•Evaluation of the nominees will be based primarily upon the information submitted in the nomination form; however, Review Committee members' personal knowledge of the nominees will also be considered.

- •If a candidate is not selected this year, the individual can be nominated in future years; however, a new nomination form must be submitted for each year.
- •Past Citizen of the Year award winners are not eligible for subsequent nominations.
- Posthumous nominations are ineligible.
- •All nominations will be kept confidential.
- •Only Completed applications will be accepted and reviewed for consideration.
